Factors that will be considered when awarding scholarships include, but are not limited to: size of agency's operating budget, size of development budget, staff size and the number of people served by the agency; or recent loss of employment.

A Scholarship Selection Committee will make an impartial determination of scholarship winners. Both the application process and the award will remain confidential.
